If during a calendar month one or more traffic peaks exceed the ordered bandwidth, LU-CIX ASBL is entitled to invoice the corresponding bandwidth service. If during 3 successive months the member traffic peaks exceed the ordered bandwidth, LU-CIX ASBL is entitled to upgrade and invoice the member's service to the corresponding traffic peaks.

The minimum contract duration is 1 year as from the date on which the recurring charges have been invoiced for the first time (the anniversary date). After the first year the contract will be automatically renewed for successive 1-year periods if not cancelled by a party. Each party can cancel the contract at anniversary date with a 3 months prior cancellation notice. The service is invoiced on a yearly basis.
